2007 - 2008 FAIR SHARE SELF-RATING SCHEDULE

It's as easy as 1 - 2 - 3 - to calculate your Fair Share Investment into CACCE! This self-rating schedule is the great equalizer in making CACCE affordable for all size chambers. Just answer the following three questions, and add up the points to get your fair share amount.

1. Locate the point totals that correspond with your chamber's position in the **Total Income** list.
2. Locate the total points that correspond with your chamber's position on the **Billing Accounts** (members) list
3. Locate the total points that correspond with your chamber's position on the **Service Area Population** list. *This is the population of the area covered by the majority of your member firms – not necessarily city or county population.*
4. Add up the three numbers. Using the **Fair Share Support Scale** to determine your Chamber's Fair Share investment level.
5. **Remit your Fair Share by check or credit card.**
